**REPORT FROM GARD**

This is the final report relating to proceedings at the Public Inquiry which ended on 18th Aug with the Closing Submissions from the main groups taking part.

I have given below a very brief summary of each submission, but at the time of submission of this copy Thames Water had not yet made their statement. This will undoubtedly contain rebuttals of almost everything others have put forward in evidence against their Water Resources Plan. The thrust of most of the objections to the Thames Water plan concerned failure to justify the proposed Upper Thames Reservoir on the basis of need, and failure properly to consider the alternatives in the event of future long term demand.

**Wren Wooster** made a brief and forceful statement, as an individual, stressing the adverse impact of the reservoir on the local community and the water which would be released by the closure of Didcot "A" Power Station in about 2015.

**The Whitewater Vale Group** (River Lodden) were concerned about abstractions from the river which meant that over 60% of the flow was sometimes treated effluent. They were keen to see reductions in abstractions. (An Environment Agency issue).

**CPRE**, which has been highly supportive of GARD throughout, directed their criticisms towards the environmental and landscape damage a reservoir would cause, stressing the severe limitations of the Strategic Environmental Assessment (SEA) provided by Thames Water.

**The Consumer Council for Water** concentrated on their concern that compulsory metering would mitigate against the poorest people and said some legislation was needed to protect this group. **The Cotswold Canal Trust** summarized the benefits and practical sense in restoring this already partially repaired heritage waterway, and then using the canal for Severn Thames water transfers. The cost would be about one quarter of the £1Bn estimated for the Abingdon reservoir.

**GARD** (45 pages of submission) set out the case most readers will know well.

There is no need for the reservoir before 2035, An addition to demand of 100MI/d Sustainability Reductions included by Thames Water is unjustified. Scare tactics by Thames Water about fines resulting from the impact of the EU Water Framework Directive are unjustified and the company has failed properly to consider the alternatives to a reservoir. This is on the GARD Website.

**OCC and VWH**. (21 pages) The local Councils combined their evidence. They summarized their strong objections to the SAE which was inadequate and strongly biased towards the Abingdon reservoir in content, omissions and the overall presentation of charts and criteria.

**The Environment Agency** (82 pages) concentrated on the failure of Thames water to follow EA guidelines and said the plan was not fit for purpose or robust, with opaque judgements, and the preferred option not demonstrated to be the best.

**Thames Water** squirmed throughout but will no doubt bite back!(125 pages).We will now have await the Inspectors Report due some time in the next few months.
